ASSIGNMENT OF BENEFITS AND FINANCIAL RESPONSIBILITY: I hereby assign all medical and/or benefits, to include major medical benefits to which entitled, including Medicare, private and group insurance or other health plans to Madison Street Surgery Center and the anesthesia provider, if applicable. Except as prohibited by any agreement between my insurance company and Madison Street Surgery Center or by state or federal law, I agree to be responsible for co-payments, deductibles or other charges for medical services not covered or paid by insurance or third party payers. I authorize Madison Street Surgery Center to file any claims for payment of patient bills and assign all rights and benefits to Madison Street Surgery as appropriate. I further agree, subject to state or federal law, to pay all costs, attorney fee expenses and interest in the event that Madison Street Surgery Center has to take action to collect the same because of my failure to pay incurred charges.

RELEASE OF INFORMATION: A photocopy of this assignment to be considered as valid as an original and revocable by me only in writing. I hereby authorize said assignees to release all information to secure payment.

WAIVER OF RESPONSIBILITY FOR PERSONAL VALUABLES: I understand that Madison Street Surgery Center does not assume any responsibility for the loss or damage to my personal property unless it is accepted in writing by Madison Street Surgery Center.

PATIENT RIGHTS AND PRIVACY: I understand that I have the right to refuse treatment and/or to change physicians and to be informed of the medical consequences of his/her action. I understand I have the right to information on Advance directives, and that the facility request copies of any advanced directives. I understand that in the event of deterioration that Madison Street Surgery Center will attempt resuscitation prior to transfer to a hospital and that advance directives will be included in transfer documents. I understand that I have the right to be provided a copy of my complete patient rights upon my request. Furthermore, I acknowledge the receipt of Madison Street Surgery Center's notice of health information practices, which describes how my health information can be used or disclosed and to whom. I understand that I have the right to issue a verbal or written grievance regarding any treatment received while at the facility and that I will receive a response regarding such grievance according to facility policies.

PATIENT RESPONSIBILITIES: I understand that I will need to provide complete and accurate health information and that I am expected to follow the treatment plan prescribed my provider and participate in my care. I understand that I am expected to provide a responsible adult to transport me home after surgery involving anesthesia and to remain with me for 24 hours if recommended by my surgeon. In addition, I agree to be respectful of all the staff as well as other patients and visitors.
